Once an individual has met all the requirements of a state-approved teacher preparation program and becomes a program completer, the individual is no longer classified as enrolled.

Texas Wesleyan University's Undergraduate Education provides teacher candidates with degree programs leading to EC-6 Generalist with ESL Certification, EC-6 Bilingual, Secondary (English, History, Mathematics, Science) and All Level (Music, Spanish). This department has offered some form of elementary Bilingual certification since 1968. The department certified 20 to 30 EC-6 Bilingual pre-service teachers each year until 2013. That number was greatly reduced due to the expiration of a grant for Bilingual certification. Finally, most students in this program are first-generation college students who transfer from area community colleges such as Tarrant County (TCCD), Dallas (DCCD), Hill, and Weatherford Community Colleges.
